



RELEASE AND WAIVER- Wollundry Cycle Challenge Gears and Beers Festival

I hereby acknowledge, accept and agree that:-

1. Cycling is a dangerous recreational activity and as such by my participation in the event I agree that there is an obvious risk that I may suffer serious injury, death, loss or damage, cost or expense of any kind, including, but not limited to, refund of entry fees, in the event of extreme weather before, after or during the completion of the event and that I participate in the event at my own risk regardless of whether or not such injury or death is caused or contributed by any act or omission or negligence of Wollundry Cycling Challenge, its servants, employees, volunteers, or agents.
2. I will be cycling on public roads open to the public including vehicles and I participate in the cycling event acknowledging that there is an obvious risk that I may suffer serious injury, loss or damage as a result. Wollundry Cycling Challenge strongly recommends that you obtain personal accident insurance before taking part in the event. Wollundry Cycling Challenge also recommends that your bicycle is checked and serviced by a bicycle mechanic prior to using it in the event.
3. I acknowledge there exists a risk of loss and I or damage to my personal property by my participation in the event and that Wollundry Cycling Challenge shall not be responsible for any such loss or damage regardless of whether or not such death, injury, loss or damage is caused or contributed by any act or omission or negligence of Wollundry Cycling Challenge, its servants, employees, volunteers, or agents.
4. I will participate in the event only to a level appropriate to my fitness. If I am unsure of a safe exertion level for my fitness level will not participate in the event unless I have obtained a clearance and advice from a medical practitioner. I acknowledge and agree that Wollundry Cycling Challenge has no responsibility or liability in respect of my fitness to participate in the event and therefore I participate in the event at my own risk.
5. In the event I suffer injury I give Wollundry Cycling Challenge permission to call an ambulance on my behalf. However, Wollundry Cycling Challenge will not take responsibility for such transport being available nor the care provided. Any transport costs must be met by you. Wollundry Cycling Challenge recommends that you hold current ambulance service membership.
6. I acknowledge that Wollundry Cycling Challenge may withdraw their permission for me to continue participating in the event at any time for any reason without a refund of my entry fee. If an event official directs your withdrawal from the event, you undertake to comply with this direction immediately, including by voluntarily returning to the finish area.



7. It is my sole responsibility to ensure that I have all equipment necessary and appropriate to participate in the event, including safety helmet and footwear, and I will ensure all equipment used by me is in a sound mechanical and safe condition and complies with all relevant legislation. Any children or minors accompanying me must also wear and have a safety helmet and footwear that complies with relevant legislation. I acknowledge and agree that Wollundry Cycling Challenge has no responsibility or liability in respect of the equipment I choose to use or not use in the event.
8. During the event I must comply with the current NSW road rules and any directions given by police, cycle marshals, event co-ordinators and I or volunteers and I or officials, and will ride carefully and considerately at all times.
9. My participation in the event is at my own risk and I accept responsibility on that basis for any injury, death, loss or damage I may suffer or I may cause another person to suffer as a result whether arising from negligence or otherwise of Wollundry Cycling Challenge, or their employees, servants, volunteers, or agents or from any other cause.
10. I will indemnify and shall keep indemnified Wollundry Cycling Challenge, its employees, servants and agents against any actions or claims which may be made by me, on my behalf or by other parties for or in respect of or arising out of my death, injury, loss or damage or as a result of death, injury, loss, or damage suffered by another caused by me or my equipment whether through my negligence, breach of contract or any other manner whatsoever.
11. If I cancel my registration I will not receive a refund unless the organisers are notified in writing by email no later than 5.00 pm on Friday the 30th September at which time a 70% refund will apply. I consent to Wollundry Cycling Challenge using in any way they see fit, including advertising, any photograph, video or other media or recording of me and/or my child at the event.
12. I consent to Wollundry Cycling Challenge may use or disclose your personal information for any purposes relating to the administration or facilitation of the event
13. However, Wollundry Cycling Challenge will not disclose your personal information to any other third party not specified in these Terms and Conditions of Entry, except without your express written consent.
